The Cambridge Community Unit School District #227 Board of Education met for the regularly scheduled meeting on March 20, 2025.

The Pledge of Allegiance to the Flag was recited.

Mr. Humphrey called the meeting to order at 7:00 pm with a roll call attendance. Members present were Lance Edmund, Chad Humphrey, Culley Medley, Carrie Boelens, Dianne Jeffries, and Jarrett Schmoll. Also present were Jenna Bibb, Superintendent; Heather Pine, Elementary Principal; Bob Reagan, Jr./Sr. High School Principal; and community member Becky Blackert.

Executive Session:

At 7:01 pm, Mrs. Boelens made a motion to move to executive session for the purpose of discussing the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body, student discipline, or to fill a vacancy. Administrative Reports:

Mrs. Pine, Elementary Principal, shared information about:
